In consideration of being allowed to participate in any way in **the 2017 Dog Parade & Costume Contest** program, related events and activities, which will take place at Luna Park, 1000 Surf Avenue, Brooklyn, NY 11224, the undersigned acknowledges, appreciates, and agrees that:

- 1) My voluntary participation to the 2017 Dog Parade & Costume Contest may result in personal injury to me and/or my above mentioned dog ("Dog"), and that the risk of injury from the activities involved in this program exists.
- 2) By participating in, attending and/or observing the Contest I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, that are incidental to or in any way arise from the Contest or Parade, including, without limitation, all risks and danger inherent in a canine-oriented event (e.g., dog bites, fights or altercations, falls, contact with spectators at the Parade & Contest), EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation;
- 4) I accept full responsibility for any and all actions of the Dog and agree that the Dog will be in my care and control during the Contest and Parade;
- 5) I understand and acknowledge that Dog must have a collar and a leash must be on hand by Owner/Participant, and that there is a one dog limit per handler.
- 6) I hereby represent and confirm that the Dog is not subject of a quarantine order, a pending adjudication or administrative hearing, and has never been declared dangerous, potentially dangerous or vicious or potentially vicious Dog;

7) I willingly agree to comply with the stated and customary terms and conditions for participation, and to abide by all applicable governmental laws, ordinances, orders, directions, rules and regulation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself and/or the above mentioned Dog from participation and bring such to the attention of the nearest official immediately;

8) I acknowledge that Luna Park reserves the right to exclude or eject any and all unruly, rowdy or disruptive Owners/Participants and/or Dogs from the Contest and/or from the property without liability and that I shall be fully responsible for any damages or expenses, direct or indirect, incurred as a result of me or my Dog/s disruptive behavior and /or ejection. I further agree that any Luna Park official may authorize necessary treatment for me and/or the Dog in the event of injury;

9) I further agree to assume liability for any and all medical costs incurred as a result of my participation to the Contest that are not covered by my insurance, including but not limited to costs of medical care and treatment, ambulance services, hospital stays, and physician treatment.

10) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD Central Amusement International LLC, the City of New York, the New York City Economic Development Corporation, Apple Industrial Development Corp.,** their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (“RELEASEES”), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
